SPECIAL CONDITIONS OF ENTRY

1. Owners and riders must be "Full" financial members of the NCHA at the time of nomination
2. All conditions of the 2010 Futurity will apply with the exception of Rule 13, 19 & 22.
3. The Event is for three year old horses ridden with a Snafflebit. Bosals and Hackamores may be used (as per NCHA rule book pg 10 rule J)
4. Horses entered may not compete in the NCHA Open or Non Pro Futurity and all entries are non transferable.
5. NCHA Snafflebit Cutting contest rules will apply.
6. NCHA Snafflebit Cutting dress and equipment rules will apply.
7. There will be an Open Division only. The Open Division is open to all NCHA members with lifetime earnings of \$5,000 or less.
8. Two and a half head of cattle will be used in the Go Rounds and three in the final.
9. Snafflebit Cutting Futurity entrants will be unable to enter in the NCHA pre-works preceding the Futurity but may use practice pens.
10. Snafflebit Cutting entrants and horses may have shown in two handed cutting events prior to this event.
11. The event will have 2 complete Go Rounds with the top 10 aggregate scores from the Go Rounds to compete in the clean slate final. This rule overrides rule 15 NCHA aged events.
12. Payout will be as per NCHA rule book page 48, rule 15.
13. Amount payable is \$350 and includes GST, this includes entry fee and office.
14. **Entries Close 01 April 2009 (1st payment \$175 by 01/03/2010 - 2nd payment \$175 by 01/04/2010)** and breed registration papers are required or a notarized statement of age description by licensed veterinarian for unregistered horses including a photograph (as per rule book 4A, page 40), upon nomination
15. **Cattle hire is additional and must be paid by 01/05/2010.**
16. There will be **NO REFUND / CARRY OVER** of entry fee.
17. Each rider is restricted to 2 horses only in this competition.
18. Payments must be made on or before the due date. There are no exceptions to this rule. Late fees will be 50% extra.
19. **1st and 2nd Go Rounds Thursday 27th May. Final Friday 28th May.**
20. The NCHA reserves the right to alter the program should unforeseen circumstances occur.
