1. All owners and riders must be full financial members of the NCHA.
 2. A surcharge of 50% will apply for any payments not made prior to the commencement of the show. Practice pen accounts will not be opened unless a signed cheque or credit card information is provided to the Secretary.
 4. Stables are available to competing horses or turnback horses only. Sale horses will be allocated stables in Sale barn. Under NO circumstances are stables to be used for any other purpose.
 5. Entry to grounds - General admission is \$26 per adult, \$12 for 3-16 years. A TRC levy of \$36 per person for entire show will apply for all persons entering the stadium, due with Sundry Payments. Passes will not be allocated if the levy is not paid. Aged event owners will receive 2 passes for the duration of the show. Trainers will receive 2 passes for up to 5 horses and 3 passes for more than 5 horses. These passes will be mailed prior to the show.
