

NCHA SELECT SALE INCENTIVE FOR 2011 FUTURITY AND NON PRO FUTURITY PROSPECTS

A sale incentive consisting of \$10,000 will be paid to the owner of the highest scoring finalist bought from the 2010 NCHA Select Sale and \$5,000 to the vendor of that same horse in each of the Open and Non Pro Futurity events. In the case of a tied score in the finals between two horses bought through the sale the above bonus money will be shared equally.
