Terms and Conditions: Please read all conditions of entry, as nominating for an event confirms your AGREEMENT to all conditions of entry for Wildhorse Cutting Inc. 2025 show.

Conditions of Entry Championship show & event grounds:

- 1. Payment in full must be received for entries to be included in to the draw.**
- 2. Scratching accepted till 11.59am 12th August for full refund. Scratching's after this date will not be refunded, unless approved by Show President.**
- 3. All championship show entries and events will be run in accordance with the NCHA Ltd rulebook.**
- 4. Any person riding a horse anywhere on the grounds must be a member of NCHA Ltd. Lopers and assistants are included in this requirement. Under no circumstances are non- members to mount a horse at an approved NCHA Ltd event. Show membership is available at \$40 a day and waiver forms must be completed either by completing on I compete or at show office, a Show membership covers covers the rider/competitor/groom for the entirety of your event.**
- 5. ReRun cattle: WildHorse Cutting Inc committee reserves the right to use rerun cattle if required for any event pending nominations and cattle numbers available. All Competitors will be reimbursed 50% of the cattle hire in those events, as described in the NCHA Ltd rulebook.**
- 6. Youth event: Junior youth and Senior youth will run together, if less than 17 nominations; placings will be allocated to each category and the added money will be split 50% each. There is no office fee or entry fee for the youth, WildHorse Cutting Inc. sponsors these fees for the Youth events.**
- 7. Wildhorse Cutting Inc. reserves the right to alter the program (including start and finish times) at any time prior and during the event due to entries, daylight restrictions, cattle availability, and local government requirements.**
- 8. All prize payouts will be in accordance with the NCHA Ltd rulebook.**
- 9. Cancellation of show prior to or at the commencement of the event, due to extreme weather, acts of God and or other circumstances out of the committee's control are communicated to the NCHA Board and approved as required by the NCHA rulebook. All entries will be refunded under these circumstances unless cattle have been transported. The Wildhorse committee reserves the right to retain the cattle hire fee under these circumstances.**

10. Wildhorse Cutting Inc. use of media: “Images, videos and or all digital recordings” taken at Wildhorse Cutting Inc. events by members of the committee are considered the property of Wildhorse Cutting Inc. Wildhorse Cutting Inc. is the owner of the copyright in the posted images and recordings and the physical images and recordings, and as such may use/distribute said media content for promotional purposes. “Images, videos and or all digital recordings” taken at Wildhorse Cutting Inc. events by a professional photographer under contract by Wildhorse Cutting Inc. may be used by Wildhorse Cutting Inc for public relations, promotions and advertising purposes as per contracted agreement. If any competitor or person at a Wildhorse Cutting Inc. event wishes to revoke their consent to the use of images and recordings they must inform the Wildhorse Cutting Inc Secretary in advance.

11. NCHA Ltd rulebook – Contestants: Item 5

No contestants, NCHA member, or other person shall engage in any form of misconduct, verbal harassment or physical aggression toward show management, judges, NCHA employees, fellow contestants or members of the public while at an affiliated show. Show management has the right to immediately disqualify, refuse entry and remove from the grounds any person who violates this rule. No entry fees, cattle hire, camping and gate charges will be refunded and any prize money won by the offender or any horse ridden by the offender may be forfeited.

Unaffiliated Snaffle Bit entry: All competitors will be judged as a two-handed cutting event, any type of saddle can be used for this event and twisted wire snaffles, gag snaffles or shank snaffles shall not be used. Snaffle bits are to be a minimum of 10mm (3/8”) and have a smooth single jointed mouthpiece. Rider’s horse must not have won more the **\$1000 dollars** in a NCHA event earnings (please check your horse’s availability prior to entry).
